FRANCHISE, LICENSE, AND ADMINISTRATION COMMITTEE MINUTES**

July 1, 2015

Trustee Fischer at the regular board meeting held on June 15, 2015 scheduled a franchise, license, and administration committee meeting to take place on July 1, 2015 at 3:45 p.m. Present at the franchise, license, and administration committee meeting was Trustee Fischer, Trustee Greenlee, Trustee Amiano, Trustee King, Trustee Littrell, Trustee Keast, Village Treasurer Riebe, Finance Director Wolf, and Economic and Development Director Cyr. Village President Schore and Village Administrator Spathis absent.

**1. LIQUOR LICENSE FOR STATUS MEN**

The committee discussed a liquor license application submitted by Status Men, a hair salon to serve beer.

Trustees: Trustee Fischer, Trustee Greenlee, Trustee Amiano, Trustee King, Trustee Littrell, and Trustee Keast denied issuing a liquor license to Status Men.

**2. GUN RANGE REZONING**


Committee discussed the current zoning of the proposed gun range. The gun range is currently zoned M-1. The Mayor's recommendation is to change the zoning to a permitted use M-2. Economic and Development Director Cyr stated the Village will need to change Zoning Code 3.1, Chapter 36 by adding a permitted use for a gun range with certain stipulations that must be met. Committee discussed that the rezoning will first go to the planning and zoning commission to allow the amended. Once amended, then the applicant can apply for the rezoning of the parcel from a M-1 to a M-2 permitted use. Committee discussed the M-2 permitted use would only rezone one of the two parcels owned by the applicant.

Trustees: Trustee Fischer, Trustee Greenlee, Trustee Amiano, Trustee King, Trustee Littrell, and Trustee Keast in favor of amending of Code 3.1, Chapter 36 by adding a permitted use M-2 zoning with certain stipulations for the proposed gun range and sending it to the Planning and Zoning Commission.
