

# Monday, July 20, 2020 Public Hearing Before the Corporate Authorities Meeting 5:15 PM

# THIS WILL BE A REMOTE/ VIRTUAL PUBLIC HEARING HELD VIA TELECONFERENCE/VIDEO CONFERENCE ON ZOOM

This Public Hearing will be conducted by audio or video conference without a physically present quorum of the Village Board because of a disaster declaration related to COVID-19 public health concerns affecting the Village of Bourbonnais. The Village President has determined that in-person meetings at the Village of Bourbonnais Board Room generally located at 700 main Street NW, Bourbonnais, Illinois, with participants being physically present, is not practical or prudent because of the disaster. The Village Board, chief legal counsel, and the Village Administrator will not be physically present at the Village of Bourbonnais Board Room, as it is unfeasible due to the disaster. The Public Hearing will be audio or video recorded and made available to the public, as provided by law. Physical public attendance at the Village of Bourbonnais Board Room generally located at 700 Main Street NW, Bourbonnais, Illinois is not feasible, so alternative arrangements for public access to hear and participate in the Public Hearing are available here:

The statement must be typed or written legibly, no more than 200 words in length, free of any abusive or obscene language; and received by the Village Clerk at the designated address prior to the commencement of such Public Hearing.
